The Wixom Municipal Code requires approval of a dimensional variance from the Zoning Board of Appeals when it can be shown that ordinance standards have been met. The property is zoned M-1, Light Industrial, where automotive technology uses are permitted in that district. The parcel number is 96-22-08-100-032.
