The Wixom Municipal Code requires approval of a dimensional variance from the Zoning Board of Appeals when it can be shown that ordinance standards have been met. The property is zoned B-3, General Business, where tire stores are permitted in that district as a special land use. The parcel number is 96-22-07-401-045.
