Sign Permit Guidelines

Plans and permit application:

1. Please remit the administrative and zoning plan review fee (**\$66 non-refundable**) as well as registration fee (**\$25 if not currently registered**) along with the completed application.
2. A separate application is required for each sign.
3. An electrical permit application should accompany the sign permit application (if necessary).
4. Upon approval, permit fees will be due (\$54 per required inspection).
5. **The sign permit will not be considered issued until drawings have been approved and balance due has been remitted.**

Review time: *The permit application is generally processed within two weeks*

A permit is required for:

- New signs (ground, monument, pole or wall)
- Replacement signs
- Vinyl window signs

Fees:

Administrative fee	\$ 39 (for each permit)
Plan Review	\$ 27 (first half hour)
Registration fee	\$ 25 (city renewal concurrent with the state licensing)
Permit fee	\$ 54 (per inspection)

Required Drawings:

1. A minimum of two (2) copies of a site plan must accompany this application. The site plan must be on a minimum of 8^{1/2}" X 11" paper and must show the property dimensions, all existing signs, their size (area, height, etc.), right-of-way lines, road edge and the location and size of any other important property characteristics, such as easements, utilities, structures, etc.
2. A minimum of two (2) copies of the rendering of the proposed sign(s) must also be submitted. Drawn to scale and showing all applicable dimensions. Drawings must be a minimum scale of one-inch (1") per one foot (1').

Sign Design & Materials (Only for VCA Districts - Section 18.16.060 of the Zoning Ordinance)

The use of materials such as wood, brass, vintage painting, and symbolic design are highly encouraged. Plastic or PVC may be used only for internally illuminated individual letters, logos or other message components provided their appearance (color, design, shape, etc.) contributes to the VCA district's intended traditional downtown design. Where any uncertainty exists, the proposed sign shall be referred to the planning commission for review and approval. Visual examples of these requirements are provided in Section 18.060.E of the Zoning Ordinance.

With the exception of illuminated individual letters, logos, or other message components as noted above all signs shall be constructed of two or more the following:

- Ceramic tile - painted or sandblasted
- Wood - carved or sandblasted
- Metal - formed, etched, cast, or engraved
- Brick or Stone - with recessed or raised lettering
- Matching or stylistically similar awnings and/or projecting signs.
- Composite Materials including Plastic, or PVC when used in combination with one of the above materials.

All signs shall have a clearly distinguishable dimensional effect to the sign. Individual letters, symbols, or logos shall be raised or recessed onto a different plane than the sign background. Flat one-dimensional signs shall be prohibited.

Sign colors shall be coordinated with other site elements including awnings and building façade. Neon colors shall be prohibited on all signs.
